Substantial Portion of the Day

"Substantial portion of the day" means at least one-third of the time the children are in attendance. Substantial portion of the day is used to ensure that children have sufficient access to play, learning materials and experiences that optimize their development. The "substantial portion of the day" does not have to occur at one time.

11 Items of the ECERS that rate substantial portion of the day

• Item # 3 Furnishings for Relaxation and Comfort

Rating 5.1 Cozy area accessible to children for a substantial portion of the day.

• Item # 5 Space for Privacy

Rating 5.2 Space for privacy accessible for use for a substantial portion of the day.

• Item # 15 Books and Pictures

Rating 5.1 A wide selection of books are accessible for a substantial portion of the day.

• Item # 19 Fine Motor

Rating 5.1 Many developmental appropriate fine motor materials of each type accessible for a substantial portion of the day.

• <u>Item #20 Art</u>

Rating 5.1 Many and varied art materials accessible for a substantial portion of the day.

Item #22 Blocks

Rating 5.4 Block area accessible for a substantial portion of the day.

• Item # 24 Dramatic Play

Rating 5.2 Materials accessible for a substantial portion of the day.

• Item # 25 Nature/ Science

5.2 Materials accessible for substantial portion of the day.

• Items #26 Math/ Numbers

Rating 5.2 Materials accessible for a substantial portion of the day.

• Item #34 Schedule

Rating 5.3 A substantial portion of the day is used for play activities. Note that routine care doesn't count for this play activities time.

• Item #35 Free Play

Rating 5.1 Free play occurs for a substantial portion of the day both indoors and outdoors.

Rating 5.3 Sand or water play available to children for at least 1 hour daily *
